- 2. Abide by all State of Wisconsin Laws, Ordinances of the County of Wood and Ordinances of the City of Wisconsin Rapids.
- 3. In consideration of participating in the Wisconsin Rapids Winter Market I hereby voluntarily release and discharge from liability arising from negligence the Moravian Church of Wisconsin Rapids and its directors, officers, parishioners, employees, agents, volunteers, participants, and all other persons or entities acting for them, (herein after collectively referred to as "Releases"), on behalf of myself and my children, parents, heirs, assigns, personal representative and estate, and I also agree as follows:
- a) I hereby voluntarily release and discharge forever and agree to indemnify and hold harmless "Releases" from any and all claims, demands, or causes of action which are in any way connected with my participation in the Wisconsin Rapids Winter Market, or use of their equipment or facilities, arising from negligence. This release does not apply to claims arising from

- a) (cont.) Intentional conduct. Should "Releases" or any acting on their behalf be required to incur attorney's fee and cost to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and cost.
- b) I represent that I have adequate insurance to cover any injury or damage I may suffer or cause while participating in the Wisconsin Rapids Winter Market, or else I agree to bear the cost of such injury or damage myself. I further represent that I have no medical or physical condition which could interfere with my safety in participating in the Wisconsin Rapids Winter Market, or else I am willing to assume and bear the cost of all risk that may be created, directly or indirectly, by any such condition.
- c) In the event that I file a lawsuit, I agree to do solely in the state where the "Releases" facility is located, and I further agree that the substantive law of the state shall apply.
- d) I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect.

By signing this Contract document, I agree that if I am hurt or my property damaged during my participation in the Wisconsin Rapids Winter Market, then I may be found by a court of law to have waived my rights to maintain a lawsuit against the parties being released on the basis of any claim for negligence.

4. I agree I will be solely, personally, and commercially be responsible for the property of Vendor and for any damage or harm to the Wisconsin Moravian Church while participating in the Wisconsin Rapids Winter Market. Vendor is encouraged to carry insurance for loss and public liability.
